**SCHEDULE "C"**

**RULES AND REGULATIONS OF**

**"TIRPUDIAN KUTUMB ALUMNI ASSOCIATION"**

1. The Definition of the Specific Words on Rules and Regulations are as under :

- A) **SOCIETY** : The Society Means "TIRPUDIAN KUTUMB ALUMNI ASSOCIATION".
- B) **PRESIDENT** : The President means the President of "TIRPUDIAN KUTUMB ALUMNI ASSOCIATION".
- C) **VICE-PRESIDENT** : The Vice-President means the Vice-President of "TIRPUDIAN KUTUMB ALUMNI ASSOCIATION".
- D) **SECRETARY** : The Secretary means the Secretary of "TIRPUDIAN KUTUMB ALUMNI ASSOCIATION".
- E) **JOINT-SECRETARY** : The Joint Secretary means the Joint Secretary of "TIRPUDIAN KUTUMB ALUMNI ASSOCIATION".
- F) **TREASURER** : The Treasurer Means the Treasurer of "TIRPUDIAN KUTUMB ALUMNI ASSOCIATION".
- G) **MEMBERS** : The member means the member of "TIRPUDIAN KUTUMB ALUMNI ASSOCIATION".
- H) **GENERAL BODY** : The General Body member Means the General Body of "TIRPUDIAN KUTUMB ALUMNI ASSOCIATION".

2. **JURISDICTION** : The jurisdiction of the Society will be territory of India.

3. **ACCOUNTING YEAR** : The Accounting year will be from 1st April, to 31 March.

4. **MEMBERSHIP AND ITS ENROLLMENT** : All passed out students from final year of Bachelor of Hotel Management and Catering

21. **PERCENTAGE OF EXPENSE OF OBJECT** :- Percentage of expense shall be spend on Sports 30%, Social 20%, Educational 50%. The percentage of expenses out of the income of the Society can be varied however, the same shall require the resolution of the governing body supported by the sufficient and concrete reasons.

22. **PROVISION FOR SALE OR PURCHASE OR IMMOVABLE PROPERTY** :- The society can sale or purchase any property if necessary. For sale of the immovable property, prior permission of the Joint Charity Commissioner, Nagpur, will be necessary. Before Sale of the immovable property, it is necessary to resolve unanimously or by 2/3<sup>rd</sup> majority in the Governing Body Meeting and Special General Meeting.

23. **BANK ACCOUNT** :- Funds of the society shall be deposited in nationalized or co-operative Bank or any Scheduled Bank. The account of the society shall be operated jointly by two office bearers i.e. **President and Treasurer**.

24. **LIST OF MEMBERS** :- List of members as required under section 15 of the societies registration act 1860, shall be maintained in the scheduled 6 prescribed under rule 15 of the Societies Registration (Maharashtra) rules, 1971.

25. **AMENDMENT OF CONSTITUTION** :- Any change in the constitution can be made by 3/5<sup>th</sup> majority in General Body Meeting, Procedure as laid down in section 12 of the societies registration act 1860, shall be followed.

26. **AMENDMENT OF OBJECTS/CHANGE IN NAME** :- As and when the objects and or name of the society is to be changed or the society is to be amalgamated wholly with other society, the procedure laid down in the section 12 and 12-A of the societies registration act 1860, shall be followed.

27. **DISSOLUTION** :- When the society is to be dissolved, procedure as resolution shall required to be passed by 3/5<sup>th</sup> majority in the General Body Meeting. At the same time account shall be finalized and the remaining amount/property if any shall be donated to any other charitable registered society, procedure laid down in the




