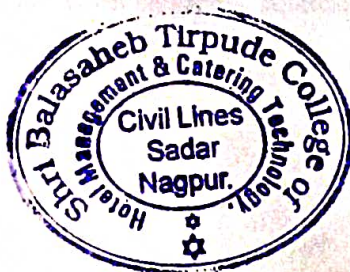
The Anti-Ragging Squad of office bearers will work under the Supervision of Anti Ragging Committee and to engage in the works of checking the entire college campus.
