double cost/ price of the books(s).

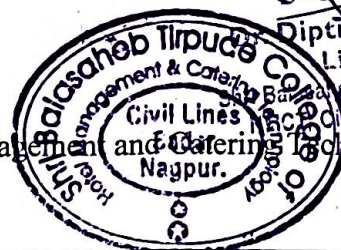
5) Only Librarian of both the Colleges, through Principal can request for Inter Library Loan.
