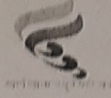
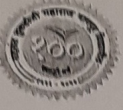

Acad/ 23/16 दिनांक २७ जानेवारी २०२३ रोजी निर्गमित करण्यात आली आहे. यानंतर अभ्यासमंडळाची प्रथम सभा आयोजित करण्यात आली होती. अभ्यासमंडळाने प्रथम सभेत अधिनियमातील कलम ४०(२) (घ) (दोन) व (तीन)च्या तरतुदनुसार अभ्यासमंडळावर सदस्यांची स्विकृती केली होती. याबाबत अधिसूचना क्र. उपरोक्त नुसार अभ्यासमंडळ सदस्याबाबत वेळोवेळी अधिसूचना निर्गमित झालेल्या आहेत. परंतु यातील खालील अभ्यासमंडळावर अध्यक्षकारिता महाराष्ट्र शासन राजपत्र असाधारण भाग चार-ब (असाधारण क्रमांक १०९) अन्वये निर्गमित अधिसूचनेतील तरतुदी नुसार पात्र व्यक्ती मिळाले नसल्यामुळे या अभ्यासमंडळावर नियमित अध्यक्ष नाहीत. करिता अधिनियमातील तरतुदीनुसार विद्यापीठातील विविध विषयांच्या परीक्षा समित्या, संशोधन व मान्यता समित्या व इतर वैधानिक समित्यावरील कामे करण्यास अडथळा निर्माण होत असतो.




