Point No. 5. Discussion on taking written Affidavit/self-declaration by students and parents for non-involvement in any ragging activity.

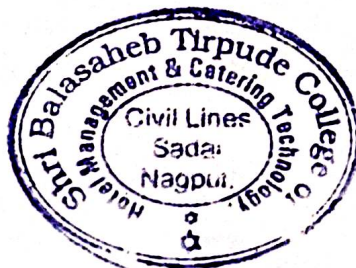

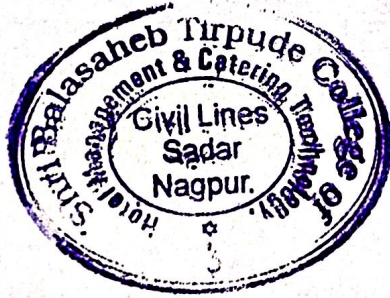
