Clarification: The institute has already excluded Librarian, physical education director and B.Lib.Sc., M.Lib.Sc., B.P.Ed., M.P.Ed., etc. Teaching Hours of the Adhoc teacher mentioned in the DVV goes to 90% of work load but statutory number of work hours are not reaching to 90% as the Adhoc Teacher present in college during his lectures only.
